Mr. Balestracci discussed the success of the afterschool programs. He also discussed the seniors who are engaged in the 13<sup>th</sup> Year program at Upper Cape Tech as the pilot program began on Monday.

Ms. Kuechler took the agenda out of order and invited the presentation by Dr. Bettencourt and the students of Elizabeth Hastings Middle School regarding Open Air Time.
