Receive information regarding possible Middle School Athletic Program

Mr. Balestracci presented. He spoke of the possibility of joining middle school athletics in the spring. The Committee agreed to pursue.

Receive update regarding Fall Town Meeting Request

Mrs. Kohler presented. She stated that the Article that we proposed regarding the \$58,000 from the Special Education Stabilization Fund replenishment will be moving forward at the next Town Meeting.

Receive update regarding MCAS Recovery Data

Mr. Balestracci presented. He explained that MCAS is a little bit different this year in terms of how we view the data and measuring growth and purposes of what they are calling loss of net gain during the pandemic years. He reviewed the data with the Committee and stated that the state overall went down in ELA, but remained steady in Math. He stated that per the given data we are in pretty good shape comparatively to the state. The Math results were excellent in the District. We are double digits above state in most grade levels. This was for the 2022 data. Mrs. Kohler reviewed the Recovery Data. Mrs. Kohler reviewed the data with the committee going over the numbers from 2019-2020, 2020-2021, and 2021-2022. She explained how the State was comparing the data from the years. Mr. Balestracci also explained how we fared against the State in Math and ELA. For the most part in Fairhaven, we have fared well against the State. It appears grade 3 was the only anomaly and we will be digging into find the why of those results. Mr. Veitch reminded everyone of where those grade 3 children were at during the pandemic and if that could have had an impact. Mrs. Kohler agreed and is looking into it. Mr. Bueno made a statement regarding the trajectory seeming equal across the schools as a whole. Mrs. Kohler also stated that we have shared the data with the Principals and we are all looking into ways to promote growth with all students, at each and every grade level. There was discussion regarding the Commissioner's decisions regarding the weight of the MCAS.

Receive Superintendent's goals

Mrs. Kohler will be giving an overview of her goals. Mrs. Kohler would like to remain active in NSIP and finish year 2. The next area she would like to be proactive in is Finance and Budget. She would like to be able to help guide our budget going forward since we face the challenge of ESSER funds falling away. The four parts she would like to be a part of her evaluations are the College and Career aspect at the high school, partnerships with Upper Cape Tech, the Culture and Climate, ensuring all families feel seen. She also wants to look deeper into engagement and what defines true engagement. Mr. Monroe questioned the proposed Middle School Athletic Program since we may be forced to cut things in the future. Mrs. Kohler stated she is looking at that program from the side of student engagement.
