The meeting was called to order by the Chair at 6:30 p.m.

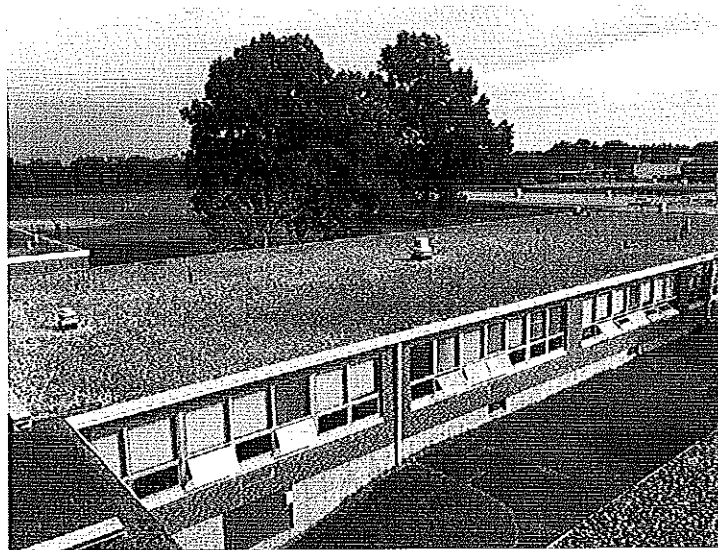

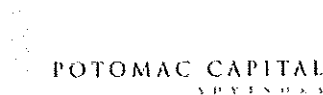

I. EXECUTIVE SUMMARY

CGKV Architects, Inc. and its team of consultants were assigned to the Town of Fairhaven to provide Designer Services for the MSBA Accelerated Repair Program project at Hastings Middle School. The project generally consists of replacement of portions of the existing roofing system.

The original sections of Hastings Middle School were constructed ca. 1958. Additions completed in 1964 brought the total building area to around 90,000 square feet. Roof replacement under this current Accelerated Repair Program project is intended to occur at the 1958 “Library Wing” (the north wing of the original building) and at the 1964 “Auditorium Wing”.

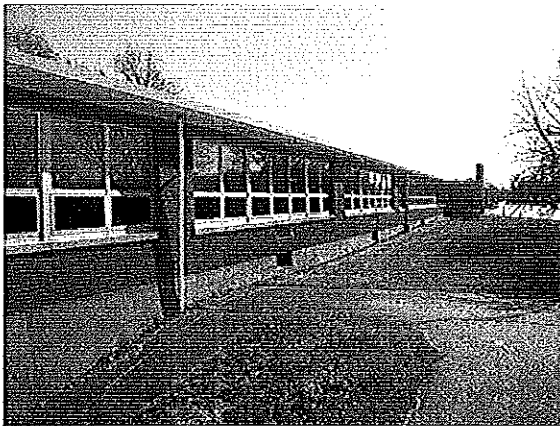


Figure I-01: 1958 Library Wing.

CGKV directed eight exploratory test cuts to confirm the composition of the current roof assemblies at the two main areas considered for replacement. Test cuts were very consistent throughout the auditorium wing roof and throughout the library wing roof. The District also possessed drawings from the 1964 addition project which were a helpful resource in investigating and understanding the existing building construction.

Most of the flat roof areas of Hastings Middle School are currently covered with built-up (or similar) roofing assemblies, and the District expressed an initial preference to install new built-up roofing assemblies at the auditorium and library wings. However, the District ultimately decided that the higher cost associated with built-up roofing systems could not be justified and elected to proceed with a single ply thermoplastic roof membrane for installation under this project.

Roof replacement will start with the complete removal of the existing roofing assemblies all the way down to the structural deck. The roof deck of the 1964 portions is poured gypsum over fiber form boards (Tectum) spanning steel bulb tees, while the older 1958 library wing has a bare Tectum deck without topping. Pull tests to be executed during the 60% CDs phase will help confirm whether the replacement roof assemblies will be adhered or mechanically fastened to the structural decks. The two basic replacement roof assemblies proposed for Hastings Middle School are...

Auditorium Wing:

- 60 mil PVC membrane (adhered to cover board below)
- 1/2" high density polyisocyanurate cover board (adhered to insulation below)
- [tapered polyisocyanurate insulation at lower roof only (adhered to insulation below)]
- 2.5" minimum polyisocyanurate insulation (adhered to insulation below)
- 2" polyisocyanurate insulation (mechanically fastened [to be confirmed] to poured gypsum deck below)
- vapor retarder (adhered to poured gypsum deck below)
- existing poured gypsum deck to remain

Library Wing:

- 60 mil PVC membrane (adhered to cover board below)
- 1/2" high density polyisocyanurate cover board (adhered to insulation below)
- tapered polyisocyanurate insulation (adhered to insulation below)
- 2.5" minimum polyisocyanurate insulation (adhered to insulation below)
- 2" polyisocyanurate insulation (mechanically fastened [to be confirmed] to Tectum deck below)
- vapor retarder (adhered or loose laid)
- existing 3" Tectum deck to remain

An overall increase in insulation thicknesses throughout the roof will require removal and replacement of the existing metal edge trim (fascia). New edge trim will be heat weldable PVC coated metal. Edge trim will be higher than it is currently, requiring additional wood blocking and a double-band of metal to avoid "oil-canning".

The increased thickness of rigid insulation required to achieve the MSBA Accelerated Repair Program thermal performance standards and to improve roof drainage also necessitates that existing through-wall flashing at the auditorium wing rising brick wall at the lower roof area be raised in order to maintain membrane manufacturers' minimum

flashing heights. This masonry and flashing work, along with related masonry repairs to prevent water intrusion, will be included in the roof replacement project.

The total estimated construction cost for the improvements explored in this Feasibility Study / Schematic Design Report for an Accelerated Repair Program project at Hastings Middle School is approximately \$634,000.

We look forward to working with the District, the OPM, and the MSBA toward a successful and beneficial project at Hastings Middle School.
